#### **ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Nirmala Chitta Teachers' Training Institute, Plot No- 1673, Vill- Pabra, PO- Tentulhiti, Tehsil/Taluka –Para, Town/City: Purulia Dist-: Purulia West Bengal- 723155 (Code No.- ERCAPP3270) has applied for grant of recognition for B.Ed. Course online on 30-05-2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 12-06-2015.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the accuments attached therewith, the affidavit submitted and the report received from VI and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the şaid teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition to Nirmala Chitta Teachers' Training Institute, Plot No- 1673, Vill- Pabra, PO- Tentulhiti, Tehsil/Taluka –Para, Town/City: Purulia Dist-: Purulia West Bengal- 723155 for conducting B.Ed. Course of two years duration with an intake 50(One basic unit) from the academic session 2018-2019 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
  - The Endowment fund of Rs. 5 iakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- 4. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The intermation with regard to the following shall also be made available on the website, namely:
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last quarter;
  - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
  - i) The affidavit with enclosure submitted along with application;
  - j) The institution shall be free to post additional relevant information, If it so desires.
  - Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
- 7 The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 8. The institution shall make available list of students admitted on its official website.
- 9. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

## ORDER

- AND WHEREAS, recognition of the institution was withdrawn vide Order No. ER-313.41/ERCAPP3270/B.Ed./WB/2022/66819 dated 24.11.2022.
- 3. AND WHEREAS, the Appellate Authority vide Order No. F.No.-89-1/E-286005/2023 Appeal/1st Meeting, 2023 Appeal No.APPLERC202214508/117075 dated 09.02.2023, decided as under:

"Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verity the submitted documents from the concerned issuing authority."

4. AND WHEREAS, representation dated 13.02.2023 received in ERC office on dated 17.02.2023, was considered by the ERC in its 328th (Virtual) meeting of the ERC held on 12.06.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F.No.89-1/E-286005/2023 Appeal/1st Meeting, 2023, Appeal No. APPLERC202214508 dated 09.02.2023, other related documents submitted by the institution, NCTE Act 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

 The Committee noted that the withdrawal order 24.11.2022 has already been set aside by the Appellate Authority vide its Order dated 09.02.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Order be issued accordingly,"
