


- AND WHEREAS, the ERC in its 242nd meeting held on 15th 16th July, 2017 considered the
 matter and as decided, formal recognition order under clause 7(16) of the NCTE Regulation, 2014 for
 D.El.Ed. programme with an intake of 50 (one basic unit) from the academic session 2018-2019 vide
 ERC Order No. ER-242.6.44 / APP3247 /D.El.Ed./2017/54246 dated 05.09.2017.
- 3. AND WHEREAS, the institution preferred an appeal against the ERC order dated 05.09.2017. The appeal committee concluded to remanded back to ERC for revisiting the matter and modifying the recognition order dated 05.09.2017 as per eligibility of the appellant institution. The ERC in its 252nd meeting (Part-4) held on 28th February to 3rd March, 2018 considered the matter and as decided that a reasoned order be issued to the institution. Accordingly, reasoned order issued to the institution vide order No. 56439 dated 03.03.2018.
- 4. AND WHEREAS, being aggrieved the institution filed writ petition (c) No. 8980/2018 in the High Court of Delhi. The Hon'ble High Court disposed of the order dated 24.02.2020 and directed disposed the matter. In sofar as the instant case is concerned the petitioner will have to succeed as Ms. Dwivedi has not been able to draw my attention to any regulation which would obliged the petitioner to employ faculty members who possessed previous experience in there line work. Accordingly, the impugned decision is set side. The ERC will reconsider the matter in the light of the observations made above and pass requisite directions on the petitioner's application. In case the ERC convenes a meeting hereafter, the petitioner's case will be considered in that meeting.
- 5.
